Mepron<sup>®</sup> is a rumen protected D,L-Methionine source containing a 99% pure D,L-Methionine quality and several non hazardous substances rendering the D,L-Methionine rumen stable. D,L-Methionine is a naturally occurring building block of proteins ubiquitous present in nature. It is worldwide accepted as a GRAS (generally recognized as safe) substance which is the main reason for its exemption from REACH duties (annex IV listing).

The non-hazardous character of D,L-Methionine was confirmed further by several toxicity, ecotoxicity and physico-chemical studies we performed with our product and which we verified for Mepron<sup>®</sup> as can be seen from the corresponding actual MSDS.
